## FEDERALLY MANDATED ROTATION OF FINANCIAL AUDIT COMPANY MEETING - APRIL 18, 2024

As the Chair of the Hospital District Board and at the request of Heath Evans and Krystal Burge, I attended a meeting regarding the federally mandated regulation to rotate financial audit companies, which must occur every five years in order to provide a "fresh look" to ensure objectivity. The following three forensic audit companies, FORVIS (now dba BDK) Crowe and MossAdams, presented their business proposals, qualifications, longevity, and experiences as they pertained to hospital situations similar to KHI/dba KRMC and the District Board when working with a landlord lease.

The KHI Board will meet and vote on which financial audit company to utilize for their audit. And, since the Hospital District Board's audit is conducted at the same time as that of KHI/dba KRMC, a discussion will take place at the April 24, 2024 Hospital District Board meeting as per Agenda Item III.C.1.

In addition, this year's audit activities will commence in May; therefore, because time is of the essence a recommendation for approval will be put forth that the District Board utilize the same financial audit company as KHI/dba KRMC. As stated under Agenda Item III.C.1., utilization of the same audit company is more cost-effective and less counter-productive than using a different audit company to conduct the mandated §Title 48 annual audit. As has been previously discussed, the financial audits for both KHI/dba KRMC and the Hospital District need to be performed by a forensic audit company rather than a general Certified Public Accountant due to specific complexities of the audit process.

Good afternoon, Ms. Furtado.

I received your email below and your letter dated April 12, 2024. I apologize for the delayed response. I have been out of the office, somewhat unexpectedly.

I have attached a copy of Mr. Franzen's original complaint. All of my communication with Mr. Williams occurred via telephone, so I do not have any emails or other communications to provide. Mr. Williams and I spoke about two questions: whether the Board kept electronic copies of agendas, board packets, and minutes, and whether the Board can charge a fee for copying records. As to the first question, Mr. Williams informed me that the Board does not maintain electronic records. Public records law does not require an entity to keep electronic records, so I have no concerns. Regarding the second question, I confirmed that a public body may charge a reasonable fee for time, equipment/supplies, and personnel necessary to providing records, as well as any postage if the records are mailed.

Based solely on those two questions, I do not see anything that indicates violation of the Arizona public records laws. Please note that public records law and open meetings law are two separate bodies of law. Mr. Franzen's request fell under public records and not open meetings. As a result, Mr. Williams and I did not discuss open meetings law.

If you are interested, our office publishes two helpful booklets about public records law and open meetings law. Both are available on our website. I have provided the links to both. Our office also provides periodic training on both topics. If you have questions about public records or open meetings, I am happy to speak with you. If you are interested in training, please let me know.

Again, I appreciate your patience with my response.
